Take Action to Prevent Homelessness by Improving the RAFT Program:

Please cosponsor and actively support House Bill 1488 and Senate Bill 961, An Act providing upstream homelessness prevention assistance to families, youth, and adults

Sponsored by Representative Marjorie Decker and Senator Brendan Crighton

<u>House Bill 1488</u> and <u>Senate Bill 961</u>, An Act providing upstream homelessness prevention assistance to families, youth, and adults would:

- Put the Residential Assistance for Families in Transition (RAFT) homelessness prevention program into state statute and ensure that benefits are available to families and individuals earlier in a housing or utility crisis ("upstream", before a household has received a notice to guit or utility shut-off notice)
- Streamline access, improve cross-agency collaboration, and allow households to receive up to twelve months of assistance, without arbitrary dollar caps (the current cap is \$7,000/family/year, regardless of household size or rent burden)
- Require the Executive Office of Housing and Livable Communities (EOHLC) to publicly post reports on RAFT to
 increase transparency on how the program is operating and provide greater understanding of the families and
 individuals seeking RAFT assistance: how they are being referred, how many apply, how many are approved,
 how many are denied, what are their demographics, what are their rent and mortgage levels, what RAFT benefits
 they receive, and what is the housing status of participant households 6, 12, and 24 months after receiving
 financial assistance or services from RAFT

Importance of this legislation: RAFT is a homelessness prevention program administered by the Executive Office of Housing and Livable Communities and funded in the state budget via line item 7004-9316. It provides short-term financial assistance to extremely and very low-income households that are experiencing housing instability and homelessness. RAFT helps families, unaccompanied youth, elders, people with disabilities, and other households regain housing stability when facing eviction, foreclosure, loss of utilities, and other housing emergencies in the fact of decreased income and/or increased expenses.

The program serves families and individuals with incomes at or below 50% of the area median income, with at least half of the annual funding targeted at households with incomes below 30% of area median income. RAFT funding is available to eligible Massachusetts residents, regardless of immigration status, and can be used for a variety of needs, including rent or mortgage arrears, apartment start-up costs, utility costs, or other expenses to help households obtain and maintain stable housing. RAFT benefits currently are capped at \$7,000/year (down from the FY23 cap of \$10,000/year.)

Since its inception in FY05, RAFT has never been codified in state statute, leaving it vulnerable to the preferences of the Executive Branch and to the annual budget process. Additionally, since August 2022, EOHLC has required households to have a notice to quit, or be further along in the eviction process, before qualifying for back rent benefits from the program. This requirement overturns changes initially made in the FY20 budget with the successful establishment of the Upstream RAFT pilot program and moves in the opposite direction of expanded access to benefits during the peak of the COVID-19 pandemic that included upstream rent, utility, and foreclosure assistance and help with forward rent. This bill would make

Upstream RAFT benefits a permanent part of the program and would allow households to access assistance with forward rent payments before falling behind on rent.

Strengthening RAFT is vital to ensure that the families and individuals who are housed but at risk of housing loss and utility shutoff will be eligible to receive critical benefits. Timely and appropriately scaled resources can hold back the wave of negative consequences and trauma generated by evictions, foreclosures, and utility shutoffs. Improving RAFT is key to promoting housing equity, as Black, Latino, and other households of color across the Commonwealth are impacted disproportionately by housing instability, systemic racism, and poverty.

Bill status: The bills were filed in January 2025 and assigned to the Joint Committee on Housing on February 27, 2025. The bills were heard on July 23, 2025, and are awaiting action by the Joint Committee on Housing.
